## WHY GET CHECKING?

GET CHECKING is designed for people who currently do not have an account with a financial institution.

Maybe you have never had an account and don't know how to start.

Maybe you have had problems with an account in the past that is making it difficult to open an account now.

Having an account is:

- Safer
- More convenient
- Less expensive
- A way to access other financial services, like loans and credit.

GET CHECKING offers you the opportunity to open an account that works for you, with a participating financial institution even if you have had problems in the past.

## WHAT YOU WILL LEARN

- How to choose an account that is right for you including...
  - Low cost checking options.
  - How to avoid costly fees.
- What you need to know to keep your checking account in balance.
- How your account relationship can help you establish credit and access other services.

## HOW DO I REGISTER?

### Pre-Registration Required.

- ChexSystems report. To order, call 1-800-428-9623 or visit [www.consumerdebit.com](http://www.consumerdebit.com) to request your free copy. Ordering takes 7 to 10 days regardless of order process.
- **Proof of Restitution. Consumer reports must show outstanding balances paid or consumer must bring proof of payment to class before a certificate of completion can be issued.**
- Upon receipt of ChexSystems report, contact a provider. The website is the most accurate schedule and should be checked frequently for updates.

- Registration fees are payable with cash or money order: \$40 per person or \$60 per couple. Fees are payable at the door unless prepayment has been requested.
- **Photo identification. Graduation certificates are issued to the name on the state issued ID.**

*Note: If you have outstanding fees from a prior account, you must settle that account before opening a new one. Institutions are not required to open an account if there has been evidence of fraud on the prior account.*
